IF THE LOAN IS DEFAULTED, A \$250 DEFAULT CHARGE WILL BE ASSESSED BY SCS.

TO PAY TUITION IN FULL:

IF LOAN ARRANGEMENTS ARE NOT MADE THROUGH THE BANK, THE FULL TUITION/ FEES ARE DUE BY **JUNE 1, 2018**. A DELINQUENT FEE OF \$50.00 WILL BE ASSESSED IF YOUR PAYMENT IS NOT RECEIVED BY JUNE 1.

Dear Parents,

Metairie Bank will be handling our tuition loans.

We need one "Tuition Information Sheet" to be completed by every family. You must list all your children attending St. Christopher for the 2018/2019 school year.

PARENTS THAT FINANCE TUITION WILL BE FINANCING THROUGH METAIRIE BANK. METAIRIE BANK WILL MAIL THE "BANK ACTIVATOR" TO YOUR HOME ON APRIL 5, 2018. THIS "BANK ACTIVATOR" MUST BE VERIFIED FOR CORRECT INFORMATION, SIGNED AND RETURNED TO THE SCHOOL OFFICE BY WEDNESDAY, APRIL 12, 2018. A \$15.00 LATE CHARGE WILL BE ASSESSED IF NOT RETURNED TO THE SCHOOL OFFICE BY WEDNESDAY, APRIL 12, 2018.

If you feel you qualify as a contributing parishioner of St. Christopher Parish, please contact the rectory. (In 2017 you had to contribute \$400 for one child or \$600 for two or more children.) If you qualify for Church support from another parish, please attach your voucher (white, pink and yellow copies) with your "Tuition Information Sheet."

If you plan to pay the tuition/fees directly to St. Christopher School (due by June 1) you must still complete the "Tuition Information Sheet" and turn in with your registration form.



Dear Parishioner:

I know there has been much confusion as it relates to the Neal Meitler study and its educational and financial impact on the Archdiocesan school system, as well as your family. In an attempt to clarify the Parish support fee, which appears to be the most sensitive issue at hand, let me offer the following:

**Eligibility Policy
For
School Financial Support**

We at St. Christopher Parish united with the Archdiocese's desire to offer financial assistance to parents with children in Catholic schools. Eligibility for school financial support is based on the following qualifications:

- (1) Registered -** The family would have to be a registered member of St. Christopher Parish. This means that your family has been enrolled and completed the census form in our parish file.

- (2) Active -** To assist our parish in bringing Jesus to our community. This means that you participate in the regular activities of our parish (prayer activities, community building activities, socials, ministry groups, etc.). The minimum qualifications for active is attendance of mass on Sundays and Holydays of Obligation and participating in the life of our parish.

- (3) Supporting -** This means that you contribute regularly to the support of our parish by using our church support envelopes or check. We encourage you to be sufficiently committed to St. Christopher, as you realize that you have been blessed by faith with redemption and salvation in Jesus and you return to God the first fruits of your labor. While it is common knowledge that scripture invites us to give 10% to the Lord, we recognize the difficulties given the current economy and the cost of providing a Catholic education to your children. Our long term goal is to obtain a 4% tithe per family.

The minimum contribution for families to qualify for school financial support for the 2018/2019 School Year (2017 calendar year church contributions) will be *\$400 per child or *\$600 per family. To place in perspective, a \$600 annual contribution equates to less than \$1.65 per day.

***Anyone who feel that they should be considered for school financial support but are unable to meet these minimum levels are invited to speak with me personally.**

ST. CHRISTOPHER EXTENDED CARE PROGRAM (PK3-7TH)

The before care program in the morning will be held in the gym. Students are to be dropped off at the Johnson Street entrance and are to enter the gym immediately. No snacks/juice will be served, but parents may feel free to send a snack with the child.

After school the children will receive a snack and drink. Roll call will be held every afternoon as it is mandatory that all students report to the cafeteria by 3:20 p.m. to be present for roll call. A mandatory study hall will be in operation every afternoon and it will be supervised by a teacher. Once the student completes his homework, he will be dismissed from study hall to engage in playground activities, TV time or indoor games in the cafeteria.

The programs are run on a weekly basis. Fees are due at the end of each week! If any parent is interested in enrolling his child (children), he must complete a registration form, an emergency card and receive a handbook of information regarding specific details of the program. It will be the responsibility of the parent to familiarize themselves with the policies. A registration will be held on Uniform/Supply Sale Day in August. Date, time and additional information will be available then. If a parent is unable to attend the registration, they may request a registration packet from the office. Hopefully, these extended care programs will be of service to you, our parents, who are engaged in the work force.

LOUISIANA'S PRIVATE SCHOOL SCHOLARSHIP PROGRAM

The Louisiana Tuition Donation Rebate Program allows qualified Louisiana children to receive scholarships to qualified K-12 private schools, allowing parents to choose the school that will best prepare their children for college, careers, and for life. ACE Scholarships Louisiana is a scholarship granting organization and offers scholarships to qualified children on a first-come, first-served basis for as long as funds are available. Applications will be available on our website, www.acescholarships.org on March 1, 2017. We will accept applications through May 15, 2017.

HOW MUCH IS THE ACE SCHOLARSHIP?

It may vary slightly depending on the private school you choose, but in general the scholarship amounts are as follows:

- For grades K – 8 the scholarship is \$4,184.80 per school year, or the full amount of tuition and fees, if tuition and fees are less than \$4,184.80
- For grades 9 – 12 the scholarship is \$4,707.90 per school year, or the full amount of tuition and fees, if tuition and fees are less than \$4,707.90
